

## TANGLE-FREE BARREL PRO LIMITED GUARANTEE

This Limited Guarantee is effective for all Cerrowire Tangle-Free Barrel Pro products produced after October 1, 2023 for a period of 6 months from the date of customer's purchase of the Cerrowire Tangle-Free Barrel Pro product (the "warranty period").

Cerro Wire LLC guarantees during the warranty period that when all set up directions are precisely and correctly followed per the Cerrowire Tangle-Free Barrel Pro Operating Instructions, the circuit-size conductors inside the 55-gallon Barrel Pro will not tangle in such a way to stop the pulling process for the end user. This includes pulling circuit-size conductors from a 55-gallon Barrel Pro using manual or powered methods recommended by Cerrowire.

If while using the Cerrowire Tangle-Free Barrel Pro product in accordance with the Operating Instructions during the warranty period, the conductor, or conductors, tangle in such a way to prevent proper operation, Cerro Wire LLC will, at its option, give the customer a credit or replace the Tangle-Free Barrel Pro product with a new Tangle-Free Barrel Pro product containing the same amount and type of wire remaining in the original product barrel where the tangle occurred.

We reserve the right to (i) inspect the Cerrowire Tangle-Free Barrel Pro before agreeing to a credit or replacement; and (ii) to change the availability of this Limited Guarantee at our discretion.

LIMITATIONS: This Limited Guarantee does not cover any damage due to: (a) transportation; (b) storage; (c) improper use; (d) failure to follow the product instructions or to perform any preventive maintenance; (e) modifications; (f) unauthorized repair; (g) normal wear and tear; or (h) external causes such as accidents, abuse, or other actions or events beyond Cerrowire's reasonable control.

THIS LIMITED GUARANTEE SETS FORTH THE CUSTOMER'S SOLE REMEDY FOR CERRO WIRE LLC'S BREACH OF THIS LIMITED GUARANTEE AND CERRO WIRE LLC'S ENTIRE LIABILITY FOR ANY BREACH OF THIS LIMITED GUARANTEE. CERRO WIRE LLC'S LIABILITY SHALL UNDER NO CIRCUMSTANCES EXCEED THE ACTUAL AMOUNT PAID BY CUSTOMER FOR THE DEFECTIVE PRODUCT, NOR SHALL CERRO WIRE LLC BE LIABLE FOR ANY CONSEQUENTIAL, INCIDENTAL, SPECIAL, PUNITIVE, OR INDIRECT LOSSES, DAMAGES, COSTS, OR EXPENSES OF ANY KIND, INCLUDING WITHOUT LIMITATION LOST PROFITS OR REVENUE, WHETHER DIRECT OR INDIRECT.
